



Introduction

Joint Task Group between C1, C2 and C3

Objectives:

- To review scientific literature related to RBE, Q and WR since ICRP 92 done in 2002
- To provide advice about whether the new information would impact ICRP recommendations on radiological protection.
- The report will include both tissue-specific and stochastic endpoints.
- Epidemiology is being considered in this report.
- Relevant ICRP publications: New ICRP Publication 148 on RBE for alphaand beta-emitted radionuclides, ICRP Publication 91 on DDREF





Progress

- Ongoing: Collection of literature that informs RBE, wR, and Q discussion
- Review of the ToC for the ICRP Publication 92 report indicated that an update (rather than a full new report) would be appropriate.
- Important to explore new areas not covered in ICRP Publication 92 that would be added to the report: non-human biota, more information on tissue reactions is now available, alternatives to RBE, possibly additional information on p+ RBE
- Group has begun creating the draft of the document
